



SAMPLE BEQUEST LANGUAGE

A gift to Shenandoah National Park Trust through your will or living trust helps you ensure Shenandoah's grandeur for the future. A bequest is easy to arrange, will not alter your current lifestyle in any way, and can be easily modified to address your changing needs. Below, find sample language to help you make a gift to benefit Shenandoah.

Bequest of a Specific Dollar Amount:

Percentage Bequest:

I hereby give, devise and bequeath ___percent (___%) of my total estate, determined as of the date of my death to Shenandoah National Park Trust a non-profit organization located at PO Box 341, Charlottesville, Virginia 22902. (Tax ID #20-8685310), to be used for general purposes.

Bequest of Specific Real Estate:

Residual Bequest:

Contingent Bequest:

Retirement Plan Beneficiary Language:

Naming Shenandoah National Park Trust as the beneficiary of a qualified retirement plan asset such as a 401(k), 403(b), IRA, Keogh, or profit-sharing pension plan allows your hard-earned savings to avoid taxes and be put to their fullest use to benefit Shenandoah National Park and is easy to do.

2. Shenandoah National Park Trust as a non-profit organization beneficiary using the Tax ID #20-8685310.
3. When you have finished, please return the form to your plan administrator, and notify Shenandoah National Park Trust.
